You may not:

- Share, resell, reproduce, or distribute this content to others
- Upload content to file-sharing platforms or social media

3. Payment and Pricing

- Prices are listed in USD: Single Module (\$47), Full Program (\$210), Ultimate Package (\$427).

- Payments are processed securely via Systeme.io. All sales are final unless covered by our refund policy (see below).
