

- B) On or about April 4, 2023, Juan Merchan, Supreme Court Justice, New York County, State of New York did, in his official capacity, conspire by and between, Alvin Bragg, Prosecuting Attorney for New York County, State of New York, in his official capacity; Person portraying himself as a law enforcement officer for New York County, State of New York, in his official capacity; to deprive Donald J. Trump ("victim") of rights secured by and enumerated in the Constitution for the United States of America, when the victim was held to answer for an infamous crime by INFORMATION in lieu of indictment by a Grand Jury, as required by Clause 1 of Amendment 5 to the Constitution for the United States of America.

3. Kidnapping (Title 18 U.S.C. §1201)






