

## CRIMINAL AFFIDAVIT INSTRUCTIONS

(to be completed in BLUE INK only!)

\*BLOCK 1 & 2: Month & Year charges were filed

\*BLOCK 3: County where charges were filed

\*BLOCK 4: State where charges were filed

\*BLOCK 5: Name of person charged

\*\*NOTE: Be sure that the name is the same name in which the charges were originally filed. For example, if they used a full middle name, enter that in this block; or if no middle name was used, do not enter any middle name or initial.

Example: Charges filed as John David Smith, do NOT write John D Smith, or John Smith

\*BLOCK 6: Month & Year of arraignment

\*BLOCK 7: County where charges were filed

\*BLOCK 8: State where charges were filed

\*BLOCK 9: County where charges were filed

\*BLOCK 10: State where charges were filed

\*BLOCK 11: Agency that performed arrest

\*\*For example, Story County Sheriff's Department, Cincinnati Police Department, Oklahoma State Patrol

\*BLOCK 12: County in which arrest occurred

\*BLOCK 13: State in which arrest occurred

\*BLOCK 14: Name of person arrested (\*NOTE: see instructions BLOCK 5 regarding name)

\*BLOCK 15: Name of person completing/signing affidavit

\*\*NOTE: Use your name however you normally sign and are comfortable.

For example: Jane M Smith, Jane Smith, Jane Marie Smith

\*BLOCK 16: Day of month the affidavit is being signed

\*BLOCK 17: Month the affidavit is being signed

\*BLOCK 18: Year affidavit is being signed

\*BLOCK 19: County in which affidavit is being signed

\*BLOCK 20: State in which affidavit is being signed

\*BLOCK 21: Your normal signature IN BLUE INK ONLY!

\*BLOCK 22: Name of person signing affidavit (\*NOTE: see instructions BLOCK 15)

PLEASE NOTE: If you are signing by POWER OF ATTORNEY, write "For XXX"

after your name in Block 22. The XXX should be the exact same name as Block 5.

PLEASE REMEMBER:

**\*\*Do NOT staple\*\***

**\*\*Do NOT fold more than 2 times (1/3 page folds to fit regular size envelope)\*\***

**\*\*Provide 3 original WET signatures in BLUE INK ONLY\*\***

\*NOTE: You are welcome to ID one original & two copy if you want, but only write it in the top left corner by RED ink or stamp.

**\*\*Do NOT send anything else in envelope. There is NO NEED for any evidence or proof. The evidence is nothing more than the arrest that actually occurred, and that evidence is proven factual by this affidavit alone.**
