

Range Bud Terms of Service

Welcome to Range Bud, a mobile application designed to help golfers improve their skills through guided drills, performance tracking, and gamified learning experiences.

These Terms of Service (“Terms”) govern your access to and use of Range Bud (“App”, “Service”, “we”, “us”, or “our”).

By creating an account or using the App, you agree to be bound by these Terms.

If you do not agree to these Terms, you may not use the Service.

1. Eligibility

You must be at least 13 years of age (or the minimum legal age in your country) to use Range Bud. By using the App, you represent that you meet this age requirement and are legally capable of entering into these Terms.

2. Account Registration

To use certain features of the App, you must create an account.

You agree to:

- Provide accurate, current, and complete information during registration;
- Maintain the security of your login credentials; and
- Notify us immediately of any unauthorized use of your account.

You are responsible for all activities that occur under your account.

3. Subscriptions and Payments

Range Bud offers both monthly and annual subscription plans.

All payments are processed securely through the Apple App Store or Google Play Store, depending on your device.

- **Free Trial:** New users may receive a free trial period as stated in the App.
- **Billing:** At the end of any free trial, your chosen subscription will automatically renew unless cancelled before the renewal date.
- **Cancellations:** You can manage or cancel your subscription anytime via your app store account settings:

- iOS: Manage via Apple
- Android: Manage via Google

All prices are displayed in your local currency, inclusive of applicable taxes where required. We do not process refunds directly—refunds are handled by the respective app stores in accordance with their policies.

4. Use of the App

You agree to use Range Bud only for lawful purposes and in accordance with these Terms.

You must not:

- Copy, modify, or distribute any part of the App;
 - Use the App to engage in fraudulent, abusive, or harmful behaviour; or
 - Attempt to reverse-engineer, decompile, or tamper with the App's software or data.
