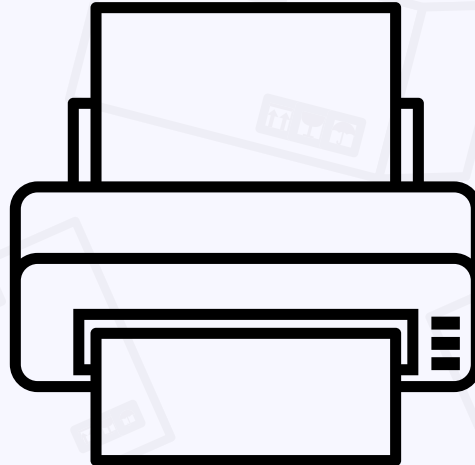

WHAT YOU'LL NEED

- AVERY 8160 LABEL SHEETS (OR SIMILAR)
- A PRINTER (NOT REQUIRED BUT RECCOMENED)
- ENVELOPES
- INTERNET ACCESS TO DOWNLOAD THE TEMPLATES
- A USPS BLUE DROPBOX NEARBY





ADDRESS FORMATTING (DELIVERY)



FORMAT THE DELIVERY ADDRESS PROPERLY

- USE ALL UPPERCASE LETTERS. ELIMINATE PUNCTUATION.
- HAND WRITTEN (BLUE INK) OR PRINTED ON LABELS

◦ EXAMPLE:

JOHN SMITH
123 MAIN ST
ANYTOWN NY 12345
USA



ADDRESS FORMATTING (RETURN)



LAWFUL RETURN ADDRESS FORMAT: HAND WRITTEN (BLUE INK) OR PRINTED ON LABELS

- JOHN DOE
 - YOUR NAME IN UPPER CASE (OR FIRST MIDDLE LAST IF PREFERRED)
- C/O: 123 MAIN STREET
 - "CARE OF" ESTABLISHES YOU'RE RECEIVING MAIL AT THIS LOCATION BUT NOT ASSERTING FEDERAL RESIDENCE
- REPUBLIC OF ILLINOIS [ZIP]
 - USE YOUR STATE IN ITS DE JURE FORM, AND BRACKET THE ZIP TO SHOW YOU'RE NOT CLAIMING TO BE IN FEDERAL ZIP JURISDICTION
- NON-DOMESTIC
 - DECLARES THAT THE SENDER IS NOT WITHIN THE FEDERAL DOMESTIC VENUE (E.G., NOT A "RESIDENT" UNDER 26 U.S. CODE)
- WITHOUT THE UNITED STATES
 - A LAWFUL NOTICE THAT THE MAIL IS BEING ROUTED OUTSIDE THE FEDERAL CORPORATION, REFERRING TO THE DISTRICT OF COLUMBIA, NOT THE 50 STATES

⚠ NOTES:

- USE BLUE INK FOR HANDWRITING (NON-COMMERCIAL, PRIVATE INTENT)
- YOU MAY ADD "PRIVATE MAIL" OR "POSTMASTER" ABOVE THE NAME IF DESIRED
- AVOID USING ABBREVIATIONS LIKE "IL" OR "USA"
- OMIT THE CITY ALL TOGETHER
- YES YOU CAN LAWFULLY FORMAT YOUR ADDRESS THIS WAY

APPLY PREPAID LABELS IN PLACE OF POSTAGE



DOWNLOAD AND PRINT THE PROVIDED PREPAID LABELS & TEMPLATES. AFFIX THEM NEATLY IN THE TOP RIGHT OF THE ENVELOPE.

HANDWRITTEN EXAMPLE + LABEL ALTERNATIVES



SEND IT TODAY — EVEN WITHOUT PRINTED LABELS

YOU DON'T NEED A PRINTER TO START. THIS SAMPLE SHOWS A PROPERLY FORMATTED HANDWRITTEN ENVELOPE, INCLUDING A LAWFUL RETURN ADDRESS USING WITHOUT THE UNITED STATES.

IN THE POSTAGE AREA, YOU CAN HANDWRITE INTERNATIONALLY RECOGNIZED PHRASES LIKE:

- "ON HER MAJESTY'S SERVICE"
- "TAXE PERCUE" (FRENCH FOR "TAX COLLECTED")
- "POSTAGE PREPAID"

THESE MARKINGS ARE ACCEPTED UNDER USPS IMM 742 AND HAVE HISTORICALLY BEEN HONORED IN INTERNATIONAL ROUTING. USE BLUE INK AND NEAT HANDWRITING. AVOID STAMPS, ABBREVIATIONS LIKE "IL (RETURN ADDRESS)," OR HANDING IT TO A USPS CLERK.

💡 TIP: DROP IT IN A BLUE COLLECTION BOX TO ENSURE PROPER ROUTING.



DROP IT OFF



PLACE THE LETTER IN A USPS BLUE DROPBOX — DO NOT HAND IT DIRECTLY TO A CLERK. THE NON-DOMESTIC RETURN ADDRESS & POSTAGE AREA COPY/LABELS INITIATES ROUTING WITHOUT TRIGGERING POSTAGE VALIDATION.

WHY THIS WORKS

ACCORDING TO USPS IMM 742.1 AND 742.2, ITEMS ROUTED INTERNATIONALLY MAY QUALIFY FOR PREPAID STATUS WHEN PROPERLY FORMATTED. BY STRUCTURING THE ENVELOPE IN THIS PRECISE WAY, YOUR LETTER ENTERS THE SYSTEM AS A PREPAID INTERNATIONAL DOCUMENT.

INTERNATIONAL MAIL MANUAL 742 STAMPS NOT AFFIXED [{LINK TO IMM 742}](#)

- 742.1 MARKING
 - SOME ITEMS OF FOREIGN ORIGIN DO NOT BEAR POSTAGE STAMPS, BUT INSTEAD ARE MARKED "POSTAGE PAID," "ON POSTAL SERVICE," "SERVICE DES POSTES," "TAXE PERCUE" OR "TP," OR "PORT PAYE" OR "PP," FOLLOWED BY POSTMARK. THE MARKING ON HER MAJESTY'S SERVICE OR O.H.M.S. IS ALSO SOMETIMES USED. *TREAT THIS MAIL AS PREPAID.*
- 742.2 PARCELS WITHOUT POSTAGE STAMPS
 - SOME FOREIGN POST OFFICES DO NOT PUT POSTAGE STAMPS ON PARCELS. ALL SUCH PARCELS RECEIVED *MUST BE REGARDED AS PREPAID.*



TROUBLE SHOOTING AND TIPS

- IF USPS RETURNS YOUR LETTER: DOUBLE-CHECK YOUR FORMATTING AND LABEL CLARITY.
- AVOID SPEAKING WITH POSTAL CLERKS UNLESS REQUIRED. THE SYSTEM WORKS BEST WHEN DROPPED AT COLLECTION BOXES.
- USE QUALITY PRINTING FOR LABELS TO ENSURE SCAN READABILITY.
