## **Privacy Policy - Every Bird Records CIC**

Every Bird Records CIC ("we", "us", "our") is committed to safeguarding your privacy. This Privacy Policy explains how we collect, use, disclose, and protect your personal data when you use our website (https://everybirdrecords.uk/) and services, including participation in our online courses hosted via Systeme.io (https://sofa2stage.com). We process your data in accordance with the UK General Data Protection Regulation (UK GDPR), the Data Protection Act 2018, and all relevant data protection legislation.

## 1. Information We Collect and Use

**Profile Information** Depending on your use of the website, we may collect personal information such as your full name, date of birth, gender, postcode, telephone number, and email address.

We collect this information for the following purposes:

- **Registration**: To create and manage your member account. We use your name and email to register you, and your date of birth and postcode to confirm eligibility.
- **Membership Administration**: To authenticate your login and present your account details. This information is also used for technical support, investigating suspected breaches, handling complaints, and compliance with legal obligations.
- **Communication**: We send essential service messages and, if permitted by you, marketing communications. You may manage your communication preferences via your account settings or by contacting us.
- **Research and Reporting**: From time to time, we may invite you to participate in surveys, this data is used anonymously for research and reporting to funders and stakeholders.

**Member Content** You may contribute content (e.g., posts in forums, course profiles, or other materials) when using our services. This content is used to:

- Present customised experiences to you and other users.
- Improve our services and generate anonymous statistical reports.

Other members will not see your profile information unless you choose to disclose it. Our facilitators can access course-related content but do not have access to your private profile or email.

**Special Category Data** You may voluntarily provide special category data (e.g., health or ethnicity). This is collected only with your explicit consent and used in anonymised or aggregated form for statistical analysis. **Information About Others** If you provide personal information on behalf of another person (e.g., through a referral organisation), you confirm that you have their permission to do so and that they have agreed to the processing of their data as described in this policy.

**Automatically Collected Data** Our web servers collect certain technical data about your use of the site, including IP address, browser type, and page visits. This helps us improve the website experience and monitor for misuse or breaches.

**2. Legal Basis for Processing** We process your personal information primarily on the basis of your consent, which you provide during registration and continued use of the site. In some cases, processing is necessary for legal compliance or our legitimate interests, such as safeguarding or fraud prevention.

When we process special category data, we rely on your explicit consent under Article 9(2)(a) and may also process it for statistical or research purposes under Article 9(2)(j) UK GDPR.

- **3. Disclosure of Your Information** We do not share your personal data with third parties without your consent, except in the following cases:
  - To third-party service providers who assist with technical support, hosting (e.g., Systeme.io), or data migration. These parties are bound by strict confidentiality and data protection agreements.
  - Where required by law or legal process.
  - To protect our rights or the safety of users or others.

Our data processor may include:

- **Systeme.io** hosting and delivery of course content.
- Other technical providers under GDPR-compliant agreements.
- **4. Marketing** We will only send marketing communications if you explicitly opt in. You may unsubscribe at any time by using the link in the email or contacting us directly.
- **5. Data Retention** We retain your data only as long as necessary for the purposes for which it was collected. This is typically:
  - Up to three years after your last login or the closure of your account.
  - Some anonymised data may be retained for research and reporting.
- 6. Your Rights You have the right to:
  - Access your personal data
  - Correct or update inaccurate data
  - · Request deletion of your data
  - · Restrict or object to processing
  - Withdraw consent
  - Lodge a complaint with the ICO (www.ico.org.uk)
