We may collect and process the following categories of personal data:

a. Identification Data

b. Technical Data

- IP address
- Device/browser information
- Login time, course progress

c. Payment Data

Handled securely by third-party processors (Stripe, PayPal). We **do not store** your credit card information.

d. Behavioral & Usage Data

- Course navigation behavior
- Quiz responses
- Support interactions

We do not collect sensitive data (health, biometric, political, etc.).

4. HOW WE USE YOUR DATA

We use your personal data for the following purposes:

- To provide access to the digital course
- To track learning progress and unlock content
- To process secure payments
- To send email updates and support information
- To analyze usage for service improvement

We never sell or rent your data.

5. COOKIES & TRACKING

We use cookies for:

- Session management
- Traffic analytics (Google Analytics or equivalent)
- Personalization of course content

You may opt out of cookies via your browser settings or cookie banner preferences.

6. LEGAL BASIS FOR PROCESSING

Our processing relies on the following legal grounds:

7. DATA SHARING

We may share your data with:

- Course platforms (e.g., Kajabi, Systeme.io)
- Legal authorities (if required under Swiss or U.S. law)

All partners are contractually bound to maintain data confidentiality and security.

8. DATA STORAGE & SECURITY

- Data is stored securely on servers in **Switzerland**, the **EU**, or **United States** (via compliant service providers).
- We apply end-to-end encryption, password protection, and access control.
 - Only authorized staff or contractors have access to your data.

9. YOUR RIGHTS

Swiss, EU & US users have the right to:

- Access your personal data
- Rectify inaccurate data
- **Delete** your data (right to be forgotten)
- Object to data processing for marketing
- Withdraw consent at any time

10. RETENTION PERIOD

We retain your personal data for:

- 5 years for tax/legal purposes

- Or until you request deletion (unless legally restricted)

- We ensure compliance with Swiss-U.S. Data Privacy Framework,
 Standard Contractual Clauses (SCC) or equivalent agreements.
 - Transfers are made only when strictly necessary.

12. CHILDREN'S PRIVACY

This website is **not intended for users under 18**. We do not knowingly collect personal data from minors.
