

MIND SHIFTING ACADEMY: TERMS AND CONDITIONS

1) Intellectual property

- 1.1. All Mind Shifting methods, training courses and training materials relating to Mind Shifting are the intellectual property of Stephen Kent and are used by Mind Shifting LLC with his permission.

2) Trademarks

- 2.1. The trademark 'Mind Shifting' is owned by Stephen Kent and is used by Mind Shifting LLC with his permission.

3) Permissions granted to trainees

- 3.1. By purchasing any Mind Shifting training you are granted permission to use the Mind Shifting method(s) taught to you in that course on yourself or with others.
- 3.2. When using Mind Shifting with others, or when communicating about Mind Shifting in person or online, you are required to refer to the methods as Mind Shifting developed by Stevie Kent.
- 3.3. Upon completion of the *Mind Shifting Practitioner Training* you are granted permission to call yourself a Mind Shifting coach if you want to. You do not have permission to do this if you have only learned one Mind Shifting method.
- 3.4. Certified Mind Shifting coaches are entitled to publicly call themselves a Certified Mind Shifting Coach and can use Mind Shifting branded materials provided by Stephen Kent in their marketing.

4) Unauthorized use of Mind Shifting by trainees

- 4.1. You are not authorized to teach any Mind Shifting method to anyone else, or to share training videos, written instructions related to Mind Shifting with anyone else, or with any Artificial Intelligence (AI) platform. The only person authorized to teach Mind Shifting, share the Mind Shifting methods or training materials, or develop any applications related to Mind Shifting is Stephen Kent. This includes the sharing of archived Mind Shifting methods that have been upgraded and/or replaced in the Mind Shifting system.
- 4.2. You are not authorized to share videos of you using Mind Shifting methods on social media or anywhere else on the internet.
- 4.3. You are not authorized to use Mind Shifting and call it something else, or to change superficial aspects of the Mind Shifting methods and call them something else.

- 4.4. You are not authorized to use the name Mind Shifting for anything other than describing your coaching/therapy services when using the Mind Shifting system.

5) Repercussions of unauthorized use of Mind Shifting

- 5.1. Unauthorized use of the Mind Shifting methods and the trademark 'Mind Shifting' will result in:
- a. Immediate removal from the Mind Shifting Academy online course platform and the Mind Shifting Community and Mind Shifting Practitioner Training Facebook groups.
 - b. Enforced takedown of any Mind Shifting materials shared online without permission.
 - c. Exclusion from accessing any new Mind Shifting methods or training materials that may be released by Stephen Kent in the future.
 - d. Legal action, to the full extent to which it is required.

6) Payment terms

- 6.1. When paying for the *Mind Shifting Practitioner Training* by installments the trainee contractually agrees to make all payments as per the agreed schedule. Failure to do so will result in immediate removal from the Mind Shifting Academy online course platform and Mind Shifting Community and Mind Shifting Practitioner Training Facebook groups.
