

Continued Flourishing - Terms and Conditions

Effective Date: 25th July, 2025

1. Subscription Service Description

The Flourishing Way Monthly Subscription ("the Subscription") is an ongoing membership service available primarily to individuals who have completed The Flourishing Way program ("Graduates"). The Subscription provides continued access to exclusive content, resources, community features, and ongoing support materials.

2. Eligibility

- This Subscription is primarily available to Graduates of The Flourishing Way program
- Subscribers must be at least 18 years of age or have parental/guardian consent
- Verification of program completion may be required before activation

3. Subscription Terms and Pricing

- **Billing Cycle:** Monthly subscription with automatic renewal
- **Subscription Fee:** \$42 per month (plus applicable taxes)
- **Payment:** Charged automatically to your designated payment method on the same date each month
- **Price Changes:** We reserve the right to modify subscription fees with 30 days' written notice to subscribers

4. Payment and Billing

- **Automatic Renewal:** Your subscription will automatically renew each month unless cancelled
