## Terms & Conditions

Her Money Pot LLC

Please read these Terms and Conditions carefully before completing your enrollment in the Her Money Pot Program. By purchasing the program, you acknowledge that you have read, understood, and agree to be bound by these terms.

# 1. PROGRAM OVERVIEW

---

The Her Money Pot Program ("The Program") is a 24-week (6-month) comprehensive program operated by April Hunter and Her Money Pot LLC, including its associates and contractors (collectively, "Company," "we," "our"). The Program provides participants with personalized support in the areas of business energetics, financial foundations, human design, and personal development.

**What's Included:**

- Personal Human Design reading
- Business Design reading
- Channeled Business Message
- Bi-weekly live coaching calls
- Custom financial dashboard
- Income map and revenue modeling
- Revenue leak elimination
- Private community support and resource library access
- Assessment Call to determine starting point

**Program Duration:** 24 weeks, beginning April 1, 2026. Your specific start date may vary based on enrollment date. Participants who enroll before April 1st are eligible for the Tax Organization Challenge (March 30 – April 1, 2026).

# 2. INVESTMENT & PAYMENT TERMS

---

**Program Investment: \$1,497.00 USD**

**Payment Options:**

**Option 1 — Pay in Full:** A single payment of \$1,497.00 due at the time of enrollment.

**Option 2 — 3-Payment Plan:** Three (3) payments of \$499.00 each. Your first payment is due at the time of enrollment. Subsequent payments are automatically charged monthly.

**Option 3 — 6-Payment Plan:** Six (6) payments of \$250.00 each. Your first payment is due at the time of enrollment. Subsequent payments are automatically charged monthly.

**Option 4 — 10-Month Payment Plan:** Approximately \$150.00 per month for 10 months. Your first payment is due at the time of enrollment. Subsequent payments are automatically charged on the same date each month.

**10-Month Plan Special Terms:** No payment is due during your birthday month. No payment is due in December. These months are automatically skipped in your billing cycle, extending your payment schedule accordingly. This applies to the 10-month payment plan only.

**All Payment Plans:** All payment plans represent a financing arrangement for the full program investment of \$1,497.00 (or applicable plan total). They are not monthly subscriptions. All scheduled payments remain due regardless of continued participation.

**Failed Payments:** If a scheduled payment fails, you will be notified and given 7 days to update your payment method. Access to program resources and calls may be paused until payment is resolved. Two consecutive failed payments may result in program removal.

**Payment Processing:** All payments are processed through Systeme.io. By enrolling, you authorize the Company to charge the payment method on file according to the payment schedule selected at checkout.

### 3. REFUND & CANCELLATION POLICY

---

**72-Hour Cooling Off Period:** You may request a full refund within 72 hours of your initial enrollment, no questions asked. To request a cooling-off refund, email [ahunter@thebeaconrock.com](mailto:ahunter@thebeaconrock.com) within 72 hours of your purchase timestamp.

**30-Day Refund Window:** Between 72 hours and 30 calendar days from enrollment, you may request a refund provided that no personalized deliverable has been provided to you. Personalized deliverables include your Human Design reading, Business Design reading, channeled business message, or custom financial dashboard. Once any personalized deliverable has been provided, the refund window closes immediately, regardless of the 30-day timeline. **After 30 Days:** No refunds will be issued after 30 calendar days from the date of enrollment, regardless of participation level or program completion status.

**Payment Plan Cancellation:** If you are on the 10-month payment plan and wish to discontinue, all remaining payments remain due. The payment plan is a financing arrangement for the full program investment of \$1,497.00, not a monthly subscription. Failure to complete payment plan installments does not constitute cancellation of your financial obligation. You may contact us to discuss hardship arrangements on a case-by-case basis.

**Dispute Resolution:** By purchasing the Program, you agree to contact the Company directly at [ahunter@thebeaconrock.com](mailto:ahunter@thebeaconrock.com) to resolve any billing concerns, dissatisfaction, or disputes before initiating a chargeback or dispute with your payment provider, credit card company, or bank. The Company commits to responding to all billing inquiries within 48 business hours. Chargebacks or payment disputes initiated without prior good-faith communication with the Company may be contested and may result in removal from the Program.

**Program Removal:** The Company reserves the right to remove a participant from the Program for violation of the Code of Conduct (Section 5) or for initiating a chargeback without prior communication. In the event of removal, no refund will be issued for services already rendered.

### 4. PROGRAM SCHEDULE & DELIVERY

---

The Program is delivered over 24 weeks through a combination of live Zoom calls, personalized one-on-one sessions, and self-paced resources. The general cadence includes:

- Bi-weekly live coaching calls (group format, via Zoom)
- Assessment Call (one-on-one, scheduled after enrollment)
- Human Design reading (one-on-one, scheduled after Assessment)
- Business Design reading (one-on-one, scheduled after Assessment)
- Channeled Business Message (delivered after Assessment)

- Custom financial dashboard (built during the program)

Call schedules will be communicated via email. All group calls are recorded and made available in the resource library within 24 hours. Personalized sessions (readings, channeled messages) are not recorded unless both parties agree.

**Missed Calls:** If you miss a live coaching call, the recording will be available. However, consistent attendance is strongly encouraged as the group energy and live interaction are central to the program experience.

## 5. CODE OF CONDUCT

The Program is a space for growth, honesty, and transformation. By enrolling, you agree to the following:

**Respect:** Treat all participants, facilitators, and guests with kindness. We honor every woman's journey without judgment.

**Confidentiality:** What is shared in Program calls stays in the Program. Do not share another participant's personal stories, financial details, or business information outside of our community without their explicit permission.

**No Solicitation:** The Program is not a sales floor. Participants may not use calls, chat, or resource areas to promote their own products or services without prior approval from the Company.

**Safe Space:** Discrimination, harassment, or behavior that undermines the safety of any participant will result in immediate review and potential removal from the Program without refund.

**Readings & Channeled Messages:** Your personal Human Design reading, Business Design reading, and channeled business message are created exclusively for you. While you may share insights from your own readings, you may not reproduce or distribute the full deliverables.

**Recordings:** Group calls may be recorded for participant access. Participants may not independently record, screenshot, or capture content from calls without prior written consent.

**Resource Access:** After the 24-week Program concludes, access to live calls and the community will transition to the alumni structure. Your personal deliverables (Human Design reading, Business Design reading, channeled message, financial dashboard) are yours to keep permanently.

## 10. MODIFICATIONS TO TERMS

The Company reserves the right to modify these Terms and Conditions at any time. Material changes will be communicated to participants via email at least 14 days prior to taking effect. Continued participation after changes take effect constitutes acceptance of the updated terms.

## 11. GOVERNING LAW

These Terms shall be governed by and construed in accordance with the laws of the state in which Her Money Pot LLC is registered, without regard to conflict of law principles. Any disputes arising from these Terms shall first be addressed through good-faith mediation before pursuing other legal remedies.
