



EVENT RELEASE AND WAIVER OF LIABILITY

Effective _____, and binding for the duration of the member's membership (or for the duration of one year from the effective date for non-members), by signing this Event Release and Waiver of Liability (the "Waiver"), and for consideration of participation of and any fee paid to attend and/or participate in any and all of the RELATIONSPOT INC.'s events including, but not limited to, Virtual On-line Meet and Greet, In-Person Get-Togethers, Social Mixers, Speed Meets, Speaker Series, Dating and Relationship Coaching and Private Facebook Group Chats ("EVENTS"), organized and hosted by RELATIONSPOT INC. (the "Host"), on a weekly and/or continuous basis at various designated locations, I,

_____, fully and completely waive and release RELATIONSPOT INC., its directors, officers, administrators, representatives, past and present employees, volunteers, agents, supervisors, participants, assigns, sponsors, its representatives and successors, members, coaches and other persons (collectively, the "Releasees"), from any and all claims, liabilities, damages, and/or causes of action arising out of an injury to me and from any and all claims, liabilities, damages, and/or causes of action arising from, or relating to, my participation and/or attendance in the Event.

Section 1. Certification of Identity. I certify that I am (a) at least 21 years of age, (b) not acting in the capacity of a reporter or agent of any form of news media, (c) not a registered sex offender, and (d) I have not been convicted of a violent crime.

Section 2. Guardianship. I (Do ____ / Do Not ____) have a Guardian (Check One/ If you have a guardian, your guardian must sign below in the designated area).

Section 7. Indemnification Clause. I AGREE TO DEFEND, INDEMNIFY AND HOLD HARMLESS THE RELEASEES FROM ANY CLAIM, LOSS, LIABILITY, DAMAGE OR COST (INCLUDING REASONABLE ATTORNEY'S FEES) TO PERSONS, ENTITIES OR PROPERTY ARISING OUT OF AND FROM MY ATTENDANCE AND/OR PARTICIPATION IN THIS EVENT.

Section 8. Assumption of Risk. I ASSUME FULL RESPONSIBILITY FOR ANY AND ALL RISK OF BODILY INJURY, ILLNESS, STI/STD, PSYCHOLOGICAL DAMAGE, DEATH OR PROPERTY DAMAGE TO MYSELF OR OTHERS ARISING OUT OF AND FROM MY ATTENDANCE AND/OR PARTICIPATION IN THIS EVENT.

Section 9. Choice of Law and Arbitration: This waiver shall be governed by and construed in accordance with the laws of the State of New York. Any disputes arising under or connected in any way to this Waiver shall be resolved exclusively through mandatory, binding, and confidential arbitration according to National Arbitration and Mediation (NAM) rules and procedures.



Section 10. Limitation of Liability. In the event that any of the Releasees are found liable to me, the total liability of the Releasees is limited to my admission fee.

Section 11. Severability. I agree that if any portion of this Waiver is deemed to be invalid, the remainder of the Waiver will still be binding and enforceable
