

Digital Income Starter Kit - Commercial-Use License Terms

Effective Date: Date of Purchase (as shown on your receipt)

1. Scope of These Terms

These License Terms govern the Start Earning Online Workbook and the Start Earning Online Blueprint sold or supplied by Castillo Digital Media, LLC ("CDM") in the Personal, Creator, and Bundle editions described below. By purchasing a Creator Edition or Complete Bundle and accepting the license terms at checkout, the purchaser ("Licensee") agrees to these terms.

2. Personal Edition - \$17

The Personal Edition of the Start Earning Online Workbook is licensed for the buyer's own personal or business use only. It may not be reproduced, resold, redistributed, repackaged, sublicensed, or transferred to another person or business. Commercial-use or resale rights are not included with the Personal Edition.

3. Creator Edition - \$47

The Creator Edition includes an editable, unwatermarked version of the Start Earning Online Workbook and a limited commercial-use license. The Licensee may modify the editable Workbook, add the Licensee's own branding, customize the content for the Licensee's audience, and sell or distribute the Licensee's finished customized version.

The Creator Edition does not grant the right to resell, distribute, sublicense, or transfer the original editable source file as an editable template, private-label-rights product, master-resale-rights product, or other product that passes commercial-use or resale rights to the Licensee's customers.

4. Complete Bundle - \$77

The Complete Bundle includes the Creator Edition Workbook described above plus an editable version of the Start Earning Online Blueprint. The Blueprint supplied with the Bundle is prepared without the Castillo Digital Media / affiliate masterclass call-to-action so the Licensee can customize the resource for the Licensee's own brand, audience, product, offer, opt-in, or next step.

The same limited commercial-use rules apply to both editable assets in the Complete Bundle: the Licensee may create and sell or distribute customized finished versions, but may not pass the editable source files or the underlying commercial-use or resale rights to customers or other third parties.

5. Requirements and Restrictions for Commercial Use

Modification required. The Creator and Bundle files are templates intended to be customized. Before resale or distribution, the Licensee must make the product the Licensee's own by replacing applicable placeholders and adding the Licensee's own branding, business information, positioning, links, and other appropriate customizations.

No claim of original authorship. The Licensee may brand and sell a properly customized finished version, but may not falsely represent that the underlying CDM template, framework, or source material was originally authored by the Licensee.

No pass-through rights. The Licensee's customers receive only the rights the Licensee grants for use of the finished product. They do not receive CDM's editable source files, this commercial-use license, or any right to resell, sublicense, transfer, or redistribute the underlying CDM templates or commercial-use rights.

Pricing expectation. CDM expects customized finished versions based on these assets to be sold at or above the current Personal Edition list price of \$17. This is a pricing expectation intended to support the value of the product ecosystem, not a guaranteed resale price or earnings representation.

CDM and third-party branding. The Licensee may not market a customized product as an official Castillo Digital Media product, use Castillo Digital Media or CDM branding in a way that implies sponsorship or endorsement, or retain CDM / affiliate-system names, links, calls-to-action, or other identifiers that are intended to be replaced in the editable edition.

6. Ownership and Intellectual Property

Castillo Digital Media, LLC retains ownership of the original templates, source material, frameworks, layout, and other intellectual property supplied by CDM. The commercial-use license is a limited license to customize and use the licensed assets as expressly permitted here; it is not a sale or transfer of CDM's underlying intellectual-property ownership.

7. Termination

CDM may terminate the commercial-use license for a material breach of these terms. Upon termination, the Licensee must stop using, selling, distributing, sublicensing, or otherwise exploiting the licensed CDM source material and any rights that depend on this license. Termination does not create new rights for the Licensee's customers or cure an unauthorized transfer of source files or resale rights.

8. Disclaimer

The licensed materials are provided "as is" without warranties of income, sales, audience growth, business results, merchant-platform approval, or fitness for a particular commercial purpose. Results depend on the Licensee's own execution, market, pricing, positioning, compliance, and other factors outside CDM's control. Nothing in these materials or License Terms constitutes legal, tax, accounting, or financial advice. Licensees are responsible for obtaining professional advice where appropriate.
