What is a Grant

They provide a service to the U.S. government and receive money for it that they don't have to repay.

Everybody wins.

MISTAKE 1

No organization will give serious money to someone who has no structure to ensure their investment lives on.

Solution: Register your business TODAY. And while you're at it, register a **non-profit**. Trust me, this is a game changer, and I'll explain why in Mistake 3.

MISTAKE 3

Not Creating a Non-Profit That Supports Your Business

Say what now?

I get it. But here's the truth: **non-profit does not mean unprofitable.** Non-profits address society's biggest challenges, and they often receive the largest funding opportunities.

Here's the best part: creating a non-profit solves Mistakes 2 and 3 at the same time.

Neglecting the Boring Stuff

Pro Tip: If your business is owned by your non-profit, you can get volunteers or sponsors to help handle the boring stuff. Don't sleep on Mistake 3—it's a total game changer.

Not Taking the Time to Plan with Patience

Let's be honest: Hustling every day feels productive, but here's the truth: 80% of your effort is only giving you 20% of your results.

The other 20% of your effort? That's bringing in 80% of your benefits.

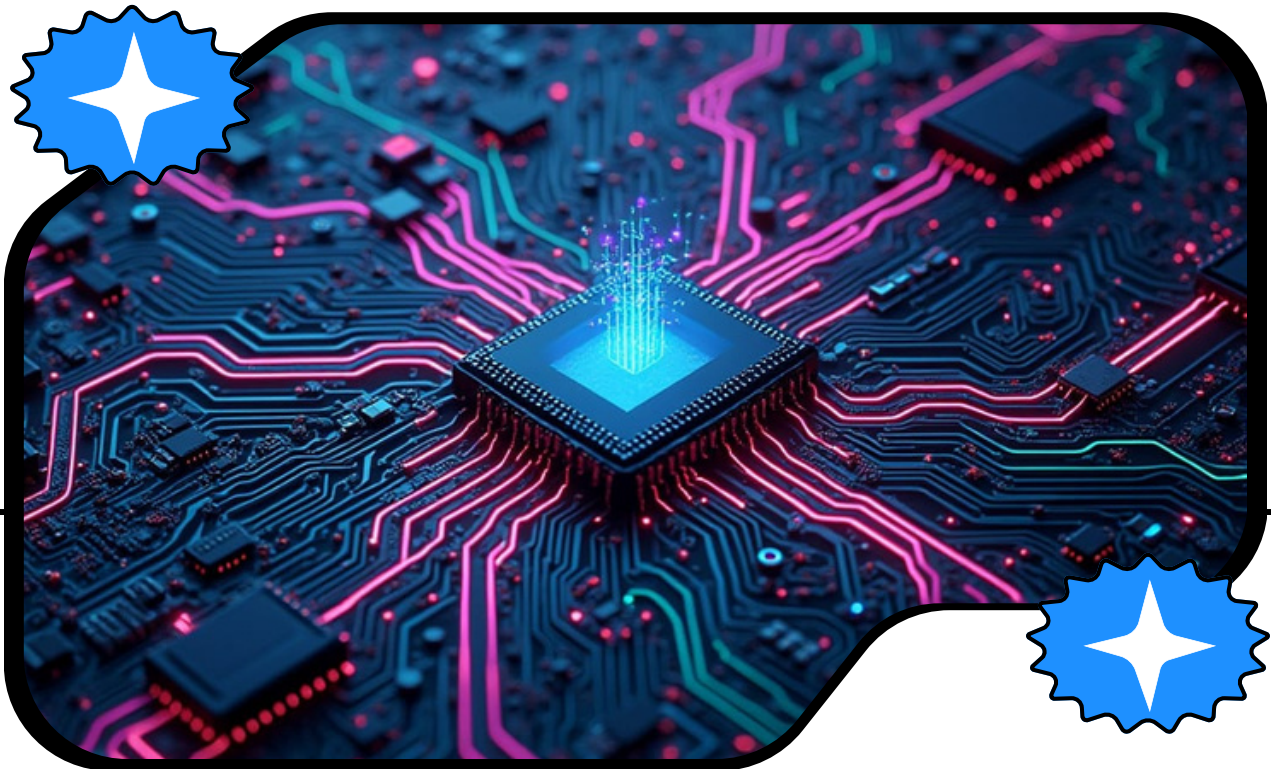
