

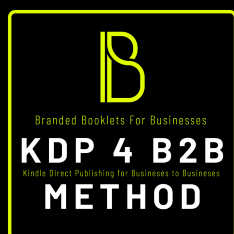

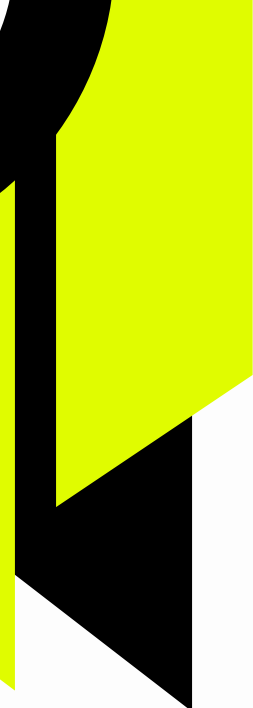

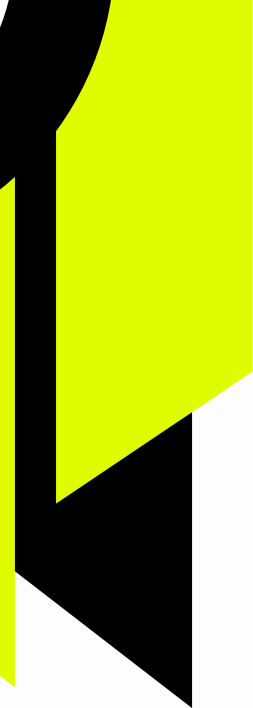

- Incorporate unique features or themes to make your books stand out.

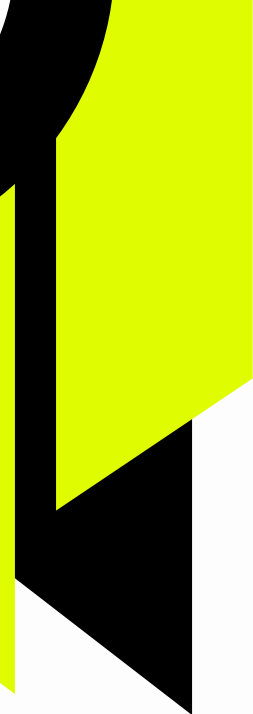

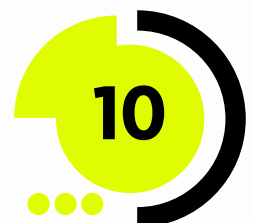
- Navigate to KDP and set up your account by providing the necessary information.
- Review and understand the tax and payment options available.

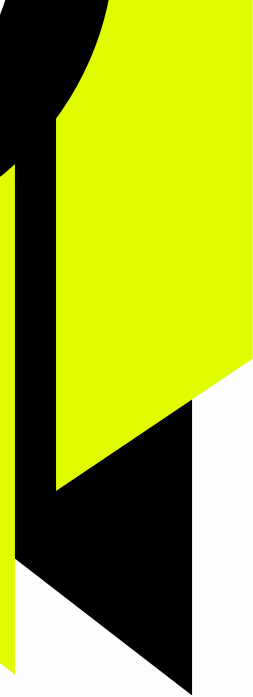




Step 8: Publish Your Low-Content Books

- Enter book details, including title, author name, description, and keywords.





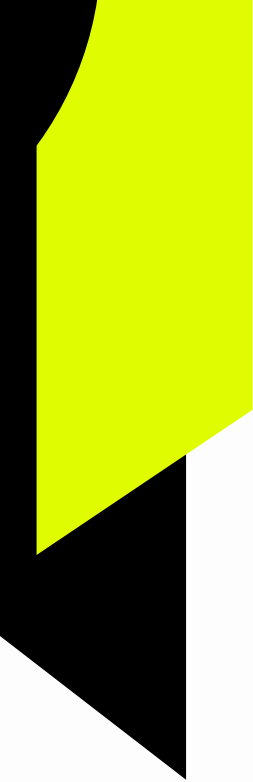
Step 9: Determine Pricing and Royalties

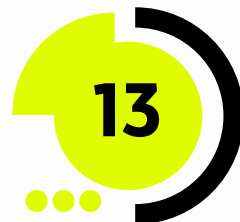
