You authorized the company to charge your credit or debit card, as indicated, as payment for your participation in the program and/or services, if the company approves your application and accepts you as a member. Furthermore, you agree that if you are accepted as a member, you are responsible for full payment of fees for the entire program and/or services regardless of whether you have selected a lump sum or monthly payment plan.

If paying monthly, there is a 12-MONTH MINIMUM COMMITMENT to join the National Association of FHA consultants. After this term, the contract will automatically renew on an annual basis depending on your payment preferences until either party gives notice in writing that they do not wish to continue the agreement with a minimum 30 days' notice. No refunds will be issued, and all monthly payments must be paid on a timely basis. If monthly payments become more than 10 days late, company reserves the right to suspend all activity on members behalf until all payments have been caught up per the payment schedule. If monthly payment becomes more than 30 days late, the entire balance becomes due and payable at day 31.

Workshops: Should a circumstance arise where you cannot attend a workshop for which you are registered or in which you were placed, your ticket is transferable to another event within one year of purchase subject to availability.

NOTICE OF CANCELLATION

YOU MAY CANCEL THIS TRANSACTION, WITHOUT ANY PENALTY OR OBLIGATION WITHIN THREE BUSINESS DAYS FROM THE DATE OF THIS ORDER FORM.

IF YOU CANCEL, ANY PROPERTY TRADED IN, ANY PAYMENTS MADE BY YOU UNDER THIS CONTRACT OF SALE, AND ANY NEGOTIABLE INSTRUMENT EXECUTED BY YOU WILL BE RETURNED WITHIN 10 BUSINESS DAYS FOLLOWING RECEIPT BY THE MERCHANT OF YOUR CANCELLATION NOTICE, AND ANY SECURITY INTEREST ARISING OUT OF THE TRANSACTION WILL BE CANCELLED.

IF YOU CANCEL, YOU MUST MAKE AVAILABLE TO THE MERCHANT AT YOUR RESIDENCE, IN SUBSTANTIALLY AS GOOD CONDITION AS WHEN RECEIVED, ANY GOODS DELIVERED TO YOU UNDER THIS CONTRACT OF SALE; OR YOU MAY IF YOU WISH COMPLY WITH THE INSTRUCTIONS OF THE MERCHANT REGARDING THE RETURN SHIPMENT OF THE GOODS AT THE MERCHANT'S EXPENSE AND RISK.

IF YOU DO NOT AGREE TO RETURN THE GOODS TO THE MERCHANT, OR IF THE MERCHANT DOES NOT PICK THEM UP WITHIN 20 DAYS OF THE DATE OF YOUR NOTICE OF CANCELLATION, YOU MAY RETAIN OR DISPOSE OF THE GOODS WITHOUT ANY FURTHER OBLIGATION. TO CANCEL THIS TRANSACTION, MAIL OR DELIVER A SIGNED AND DATED COPY OF THIS CANCELLATION NOTICE OR ANY OTHER WRITTEN NOTICE, TO CATHERINE HALL UNLIMITED INC. D/B/A NATIONAL ASSOCIATION OF FHA CONSULTANTS NO LATER THAN MIDNIGHT THREE DAYS AFTER THE DATE OF PURCHASE ON THE FRONT OF THIS ORDER FORM.
