

ROADMAP TO RICHES - TERMS AND CONDITIONS

This Terms and Conditions Agreement ("Agreement") is entered into between Daniel Radulescu dba. Digital Wealth Strategies ("Owner") and the purchaser ("Licensee") for the master resale rights digital product named Roadmap to Riches ("Product") in the jurisdiction of Greenville, SC. This Agreement sets forth the terms and conditions that govern the use and resale of the Product. By purchasing and accessing the Product, the Licensee agrees to be bound by this Agreement. If the Licensee does not agree to these terms and conditions, they may not access or use the Product.

1. Grant of License: The Owner grants the Licensee a non-exclusive, non-transferable license to use, resell, and distribute the Product according to the terms and conditions specified in this Agreement. This license is granted for the purpose of personal education and resale with master resell rights based on the specification outlined in these Terms and Conditions.

2. Ownership: The Product, including all intellectual property rights, remains the sole and exclusive property of Daniel Radulescu dba. Digital Wealth Strategies. This Agreement does not transfer ownership of the Product to the Licensee.

3. Resale Rights: The Licensee has the right to resell the Product to third parties with master resell rights, based on the specification outlined in these Terms and Conditions, provided that the Licensee adheres to the Restrictions outlined in section 4 ("Restrictions").

4. Restrictions: The Licensee is expressly prohibited from:

- Giving away the digital product for free or at a price lower than the purchase price.
- Auctioning the digital product in any form, including on websites like eBay.com.
- Modifying, editing, or altering the video content included in the Product.
- Misrepresenting or misleading customers about the Product or its origin.
- Making income claims about the Product.

5. Effective Date: This Agreement is effective as of the date of digital product purchase. The Licensee's access and use of the Product indicate their acceptance and agreement to the terms and conditions outlined in this Agreement.

6. Liability: The Product is provided "as is" without any warranties, express or implied. Daniel Radulescu dba. Digital Wealth Strategies shall not be liable for any damages arising from the use or inability to use the Product, including but not limited to direct, indirect, incidental, or consequential damages.

7. Indemnification: The Licensee agrees to indemnify, defend, and hold harmless Daniel Radulescu dba. Digital Wealth Strategies from any claims, damages, losses, liabilities, costs, or expenses arising out of or related to the Licensee's use or resale of the Product, their breach of any term in this Agreement, or their violation of any applicable law or regulation.

8. Termination: This Agreement is effective until terminated. Daniel Radulescu dba. Digital Wealth Strategies may terminate this Agreement immediately if the Licensee breaches any provision of this Agreement. Upon termination, the Licensee must cease all use, resale, and distribution of the Product and destroy any copies in their possession.

9. Governing Law and Jurisdiction: This Agreement shall be governed by and construed in accordance with the laws of the state of South Carolina. Any legal actions, claims, or disputes arising under or in connection with this Agreement shall be subject to the exclusive jurisdiction of the courts located in Greenville County, South Carolina.

10. No Refund: All sales of the Product are final. The Licensee acknowledges and agrees that there will be no refunds or exchanges provided for the purchase of the Product. Once the Licensee has purchased the Product, they are responsible for the full payment and no refunds will be issued. By purchasing and accessing the Product, the Licensee acknowledges that they have read, understood, and agree to be bound by the terms and conditions of this Agreement. If the Licensee does not agree with any provision of this Agreement, their sole recourse is to not access or use the Product.

11. Entire Agreement: This Agreement constitutes the entire agreement between the Licensee and Daniel Radulescu dba. Digital Wealth Strategies regarding the Product and supersedes all prior agreements and understandings, whether written or oral.
