

Terms and Conditions for Master Resell Rights Digital Product

These terms and conditions ("Agreement") govern the use and distribution of the digital product ("Product") offered for sale under a master resell rights license. By purchasing or using the Product, you ("Licensee") agree to be bound by the terms of this Agreement.

Grant of Master Resell Rights License:

- a. The Licensor grants the Licensee a non-exclusive, non-transferable license to resell the Product and its accompanying materials in accordance with the terms of this Agreement.
- b. The Licensee may resell the Product to end-users, granting them a personal and non-transferable license to use the Product.

Restrictions:

- a. The Licensee may not modify, adapt, translate, reverse engineer, decompile, disassemble, or create derivative works based on the Product.
- b. The Licensee may not distribute or sublicense the Product outside the scope of this Agreement.

- b. The Licensor shall not be liable for any direct, indirect, incidental, or consequential damages arising out of the use or inability to use the Product, even if advised of the possibility of such damages.

Indemnification:

- a. The Licensee agrees to indemnify and hold the Licensor harmless from any claims, damages, losses, or expenses arising out of the Licensee's use or distribution of the Product.

Termination:

- a. Either party may terminate this Agreement at any time for any reason, with written notice to the other party.

b. Upon termination, the Licensee shall cease all use and distribution of the Product and destroy any remaining copies in their possession.

Governing Law and Jurisdiction:

a. This Agreement shall be governed by and construed in accordance with the laws of [Michigan].

b. Any disputes arising out of this Agreement shall be subject to the exclusive jurisdiction of the courts of [Michigan].

Entire Agreement:

This Agreement constitutes the entire agreement between the parties regarding the subject matter hereof and supersedes all prior or contemporaneous agreements, understandings, or representations, whether written or oral.
