Grant of License:

- a) Licensor grants Licensee a non-exclusive, non-transferable license to resell the Product in its original form, allowing the Licensee to retain 100% of the profit from each sale.
- b) Licensee is permitted to make additions and enhancements to the marketing materials and promotional content related to the Product to increase its value and marketability.

Ownership and Copyright:

- a) The Product is the intellectual property of Licensor and is protected by copyright laws and international treaty provisions.

- b) Licensee shall not remove or modify any copyright, trademark, or other proprietary notices included in the Product.
- c) Licensee shall not claim copyright rights over the Product.

Support and Maintenance:

Governing Law and Jurisdiction:

This Agreement shall be governed by and construed in accordance with the laws of the United State. Any disputes arising under or in connection with this Agreement shall be subject to the exclusive jurisdiction of the courts of the United States .

Entire Agreement:

This Agreement constitutes the entire agreement between Licensor and Licensee with respect to the subject matter hereof and supersedes all prior discussions, agreements, or understandings, whether oral or written.
