

## Terms and Conditions for Master Resell Rights for Roadmap To Success

These terms and conditions ("Agreement") govern the acquisition, resale, and distribution of the digital product Roadmap To Success obtained through the master resell rights ("MRR") license. By acquiring and using the Product, you ("Licensee") agree to be bound by the terms and conditions outlined in this Agreement.

### Grant of License:

- 1.1. The Licensee is granted non-exclusive, non-transferable, and revocable rights to sell, distribute, and grant resell rights to the Product, subject to the terms of this Agreement.
