Overview of Visa Types and Residency Permits

1. NON-LUCRATIVE VISA (NLV)

The Non-Lucrative Visa is designed for individuals who wish to reside in Spain without engaging in any work or professional activities. It's ideal for retirees or those with sufficient passive income.

Key Features:

- **Purpose:** Allows residency without employment.
- **Financial Requirements:** Applicants must demonstrate sufficient financial means to support themselves. The exact amount is subject to change, so it's advisable to consult the latest guidelines.
- **Work Authorization:** Holders are not permitted to work in Spain.

2. DIGITAL NOMAD VISA

Introduced to attract remote workers, the Digital Nomad Visa allows non-EU citizens to live in Spain while working remotely for non-Spanish companies.

Key Features:

- **Purpose:** Enables remote work residency.
- **Financial Requirements:** Applicants must demonstrate a monthly income equivalent to 200% of the Spanish minimum wage. As of the latest data, this equates to approximately €2,763 per month, but it's essential to verify current figures.
- **Work Authorization:** Permits remote work for companies outside Spain.

3. GOLDEN VISA (INVESTOR VISA)

The Golden Visa program offers residency to individuals who make significant investments in Spain. However, it's important to note that this program, in its current form, is scheduled to end on April 3, 2025. There will be new options and requirements to the Golden Visa.

Key Features:

- **Purpose:** Provides residency through substantial investment.
- **Investment Threshold:** Typically requires a minimum investment of €500,000 in real estate or other qualifying assets.
- **Work Authorization:** Allows both residency and the right to work in Spain.

Application Process and Timelines

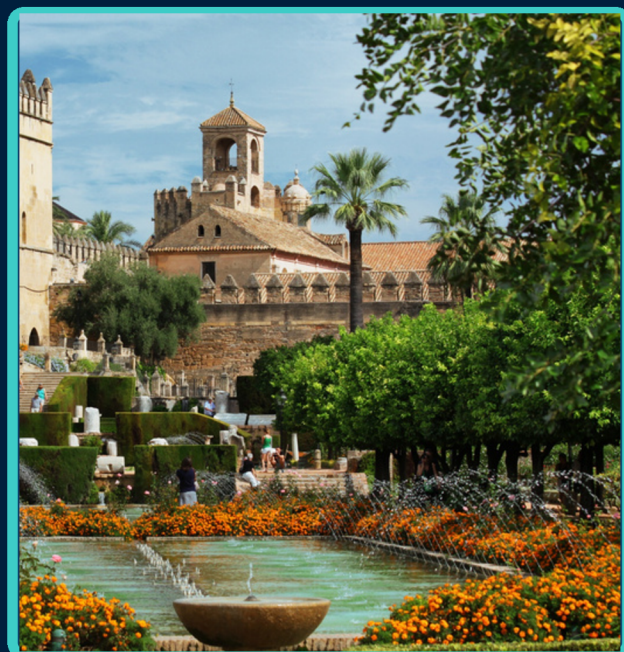


1. NON-LUCRATIVE VISA

- **Application Submission:** Must be submitted at the Spanish consulate in your country of residence.
- **Processing Time:** Typically ranges from 1 to 3 months.
- **Validity:** Initially valid for one year, with the possibility of renewal.

2. DIGITAL NOMAD VISA

- **Application Submission:** Can be initiated from abroad or within Spain.
- **Processing Time:** Varies; it's advisable to consult official sources for the most current information.
- **Validity:** Generally valid for one year, with options for renewal.



3. GOLDEN VISA

- **Application Submission:** Applications are accepted until April 3, 2025.
- **Processing Time:** Typically processed within 20 working days.
- **Validity:** Initially valid for two years, renewable thereafter.



LEGAL REQUIREMENTS FOR TEMPORARY AND PERMANENT STAYS

- **Temporary Residency:** Visas like the Non-Lucrative and Digital Nomad Visas grant temporary residency, usually requiring renewal after the initial period.
- **Permanent Residency:** After five years of continuous temporary residency, individuals may apply for permanent residency, provided they meet specific criteria.
- **Citizenship:** Eligibility for Spanish citizenship generally requires ten years of legal residency, among other conditions.
