

# Once Upon A Healing Retreat Agreement

This Agreement is entered into by and between Coach Jennifer Johnson (Jenn Johnson Coaching) and the Attendee (Client), whereby Coach agrees to provide the services for the "Once Upon A Healing" retreat.

## 1) Retreat Overview

The **Once Upon A Healing** retreat includes the following:

- **Accommodations and Dining:** Attendees will receive meals as part of the Disney Dining Plan, including:
  - 1 Quick-Service Meal per night of stay
  - 1 Table-Service Meal per night of stay
  - 1 Snack or Nonalcoholic Drink per night of stay
- In addition to the Disney Dining Plan, **Jennifer Johnson Coaching** will provide:
  - Breakfast daily (except on departure day)
  - Grab-and-go snacks throughout the retreat, as well as snacks during workshop days.
- **Note:** The Attendee is responsible for tax and gratuities on all meals, and any additional meals or snacks outside the plan are at the Attendee's own expense.
  - **Alcohol:** A variety of alcoholic spirits will be provided at no additional cost during the welcome dinner. Any other alcohol purchased during the retreat is the Attendee's responsibility.

**Meals and snacks** are determined by the number of nights included in the package stay and can be redeemed throughout the stay. Unused meals and snacks will roll over day to day but expire at midnight on the day of checkout. Meals and snacks are **non-transferable** between parties.

**Guided Inner Child Healing Exercises:** Gentle, empowering practices designed to help you connect with and nurture your inner child, offering healing and self-acceptance.

**Playful Group Activities:** Laughter-filled experiences crafted to help you let go of inhibitions, embrace joy, and build a deeper sense of community.

**Journaling & Reflection:** Thoughtful, guided prompts to help you process emotions, reflect on your experiences, and rediscover dreams long forgotten.

**Community Connection:** Build meaningful bonds with like-minded women, supporting one another through this transformative journey.

**Healing Space:** A welcoming, safe, and magical environment created to let your inner child shine, encouraging personal growth and deep healing.

**Workbook and Supplies:** Each Attendee will receive a workbook specifically designed to guide them through the retreat experience, along with all necessary supplies for the activities, ensuring a smooth and enriching journey.

## 2) Payment Terms

- **Full Payment:** The total cost of attending the retreat is due **30 days prior to arrival**.
  - **Non-Refundable:** Please note that **Once Upon A Healing** is a **non-refundable** program. No refunds will be issued for any reason, including cancellations or changes in personal circumstances.
  - **Airfare:** Airfare is **not** included in the retreat package.

## 3) Photo Release

By signing this agreement, the Attendee grants Jenn Johnson Coaching permission to use photos and videos taken during the retreat for marketing, promotional, and advertising purposes. This may include but is not limited to use on social media platforms, websites, print materials, and any other marketing collateral.

## 4) Waiver of Liability
