

Terms and conditions

Article 1: Scope

These general conditions of sale apply to all transactions concluded through the websites of the ITACWT Limited network. Any natural or legal person making an order validated via our secure payment platform, or by check or cash, is considered to be a "natural" or legal person.

Article 1a: Age limit

Age restrictions apply: ITACWT Limited only accepts clients over 16-years-old (for physical and electronic products) and over 18-years-old (for services: coaching, workshops, seminars). We do our best to restrict access to our sites, products and services to minors. Though our products and services is not of a shocking nature, we prefer to target a mature audience capable of understanding the implications and responsibilities of the business world. Similarly, any customer who does not meet these criteria will immediately be reimbursed and a return of the product(s) concerned will be required.

Article 2: Order

Article 3: Price
