### Range Rules

Clays for a Cause event staff reserve the right to alter or cancel any part of the program if the conditions warrant.

All decisions of event staff are final.

Treat all firearms as though they are loaded at all times.

Never point a firearm at anything you are not willing to destroy.

All firearms are to remain unloaded unless the shooter is on the firing line.

When not on the firing line, your gun must be empty and the action left open.

Only one team will be at the firing line at a time, as instructed by event staff.

All loading and unloading of firearms will take place on the firing line.

Maximum two shells in the gun at one time.

Shooters on the firing line shall not break 180 degrees with the muzzle of their firearm. (Under no circumstances will the muzzle point up-range).

Shooters must follow the commands of the event staff at all times.

Consumption of alcohol or intoxicants immediately before or during the event is strictly forbidden.

Eye and Ear protection are highly recommended for all persons at the event when shooting is underway.

A Parent or Guardian must accompany shooters 17 and under at all times.

Shooters are responsible for cleaning up their own hulls.

Please do not litter.

**Release of Liability**

**RELEASE FROM RESPONSIBILITY, WAIVER OF LIABILITY AND ASSUMPTION OF RISK FOR PARTICIPATION IN A DANGEROUS ACTIVITY.**

I do hereby assume full responsibility for any and all damages, injuries (including death), or losses that you may sustain or incur, if any, while attending, engaging, practicing, participating, or witnessing firearm use, shooting firearms or operation of any motorized vehicle, or any other activity and/or certain event(s) occurring in or about the premises. I hereby assume full risk, waive all claims and release and hold Clays for a Cause event, its instructors, or partners of said program and event, individually or otherwise, harmless for any and all liability, claims, suits, damages, expenses, fees, actions, or rights of action or judgements as a result of injury or death to myself or members of my family or heirs, or my guests, or damage, destruction or loss to my property, which in any way relates to, arises out of, or is in any way connected with my presence on the premises, or my participation in events of activities thereon, or the negligent acts or omissions of the releases or any other third party.

I am fully aware and understand that the Clays for a Cause event does not have on or about the premises, or employ or contract with any medical services, provisions for ordinary or emergency medical services.

In consideration of my participation in and the use of the Clays for a Cause event premises or facilities, I hereby release and covenant not to sue the owner of the premises (releasees), directors, volunteers, staff members, representatives, affiliates and lessees from any and all claims resulting from any physical injury that may occur to me while participating in the Clays for a Cause event.
