

Terms and Conditions of Sale – Antoinette Mary

Please read the following terms carefully before purchasing any digital product or service from Antoinette Mary.

Article 1: Scope of application

These General Conditions of Sale apply to all transactions concluded through the official website of **Antoinette Mary**, a business registered and operating in Ireland.

A "client" is defined as any natural or legal person who places an order and completes a payment via our secure online payment platform. By making a purchase, the client agrees to these General Conditions of Sale in full.

These terms apply to all products and services offered by Antoinette Mary, including but not limited to digital programs, coaching sessions, meditations, workshops, retreats, audio content, downloadable materials, and any other deliverables made available through our online platforms.

Certain wellness practices may require medical clearance. Please refer to Article 8 for details.

Article 1a: Age limit

Antoinette Mary's offerings are intended for clients aged **16 and over** for the purchase of digital products, and **18 and over** for participation in private services such as coaching, mentoring, workshops, retreats, or live group programs.

We are committed to maintaining a mature and responsible community. While we do not knowingly market to minors, it is the responsibility of each user to ensure they meet the minimum age requirement prior to making a purchase or signing up for any of our services.

Any newsletter subscriber found to be under 16 will be promptly removed from our mailing list upon discovery. Likewise, any customer who completes a purchase without meeting the applicable age requirement will be refunded, and access to the related product or service will be revoked.

By placing an order, the client confirms that they meet the age criteria outlined above.

Article 2: Order

By placing an order through any website, platform, or payment gateway associated with **Antoinette Mary**, the client acknowledges and fully accepts, without reservation, these General Conditions of Sale.

This acceptance applies to all purchases, whether for digital content, services, coaching, live programs, or any other offering made available by Antoinette Mary. Completion of payment constitutes a binding agreement between the client and the business.

Prices do not include any additional transaction fees or international currency conversion charges that may be applied by your payment provider. For physical goods (if applicable), shipping and handling charges may be added at checkout.

Antoinette Mary reserves the right to modify pricing at any time. However, the price applicable to a specific order shall be the price stated at the time the order is confirmed and paid.

It is the responsibility of the client to ensure that they understand the pricing currency and any associated fees charged by their financial institution.

Article 4: Payment

Payment is due in full at the time of placing the order, including for any pre-order or scheduled access products.

Accepted payment methods include **credit card** (via **Stripe**) and **PayPal**. Credit or debit cards issued by banks outside of Ireland must be internationally enabled (e.g., Visa or Mastercard). Please note that **American Express is not accepted** at this time.

All card transactions are processed securely through **Stripe**, a certified third-party payment processor. The information transmitted during payment is encrypted using industry-standard protocols and cannot be read during transmission over the network.

Antoinette Mary is not responsible for any errors, delays, or security issues related to the Stripe or PayPal platforms. By completing your payment, you agree to be bound by the terms and conditions of the selected payment provider.

Article 5: Delivery
