This privacy policy explains how JiTe Consult processes and uses personal data and what your rights are in this regard. JiTe Consult is registered with the Dutch Chamber of Commerce under KvK number 65011597, also operating under the name JiTe Consult.

We respect the privacy of our customers and website users and take it very seriously. This policy applies solely to the services provided by JiTe Consult, and not to third-party organizations mentioned on our website.

The Data Protection Officer at JiTe Consult is Jarmo Tahti.

Personal Data Collected

We only collect personal data that you voluntarily provide, which may include:

- First and/or last name
- Gender
- Company name
- Address
- Postal code
- City
- Country
- Phone number
- Instagram username
- VAT number (for international clients)
- Any additional personal data you provide (via phone, email, newsletter, or coaching calls)

We do not collect sensitive personal data.

Consequences of Not Providing Personal Data

You're not legally required to provide your personal data. However, if you do not provide the necessary data, some services may not be available to you.

Purposes for Collecting Personal Data

We collect data for the following purposes:

- Contact form submissions
- Order processing (including free resources)
- Account creation
- Newsletter subscriptions

- Customer contact
- Marketing profiles
- Contract fulfillment
- Access to restricted website areas
- Enforcing agreements
- Verifying identity for privacy rights requests

Legal Grounds for Processing

We process personal data based on the following legal grounds:

- Contractual necessity
- Your explicit consent
- Legitimate interests
- Voluntary disclosure by you

Legitimate Interest Examples

- Marketing: After purchasing a service, we may contact you about similar offerings.
- Legal claims: We may process data to detect fraud, pursue claims, or initiate legal proceedings.

You have the right to object to processing based on legitimate interest.

Cookies Used

We use cookies and similar technologies for:

- Functional purposes: to ensure the website works correctly (no consent required)
- Analytics: to gather statistics and improve user experience
- Tracking: for relevant content and advertising (consent required)

Social Media and Website

With your written consent, we may publish your name, company name, and website on our site. These can be anonymized on request. Published content may appear in search engines. Social media buttons on our site may share your data with those platforms. Your comments and posts on our social pages are publicly visible. We may share public reviews on our website without additional permission, though you can request removal.

Communities

When joining our communities, your first and last name are visible to other members. Shared information may be seen or heard by others present.

Communication

We may update you through:

- Social media
- Email
- Our newsletter (you can opt in or out)

Sharing with Third Parties

We share personal data with third parties only when necessary, including:

- Hosting providers (e.g., Vimexx, WordPress, Huddle)
- Website managers
- Payment processors
- Administrative support
- Debt collection agencies (if needed)

Third parties are not permitted to use your data for their own purposes. We do not sell your data.

Data Retention

We retain personal data only as long as necessary, including:

- During the course of an assignment
- Up to 3 years after for support or analytics
- Financial data: kept for 7 years (legal requirement)
- Consent-based data: kept for 1 month after withdrawal

Website Security

Our website uses SSL encryption and is regularly updated and scanned for vulnerabilities to ensure data protection.

Your Rights

You have the right to:

- Access your data
- Request correction or deletion
- Limit or object to processing
- Transfer your data to yourself or a third party

To exercise your rights, contact us via the email above. Include a copy of your ID (with photo, MRZ, and social security number blurred).

Withdrawal of Consent

If processing is based on your consent, you may withdraw it at any time. This does not affect any previous processing.
