



FEAST ON LIFE TRAINING PRIVACY POLICY

Protecting your private information is our priority. This Statement of Privacy applies to feastonlife.com.au and Feast on Life Training and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Feast on Life Training include feastonlife.com.au The Feast On Life website is an Online training, webinars, consults and training materials site. By using the Feast on Life Training website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Feast On Life Training may collect personally identifiable information, such as your First and Last Name and Email Address.

If you purchase Feast on Life Training's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through Feast on Life Training 's public message boards, this information may be collected and used by others. We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. These may include: (a) signing up for special offers from selected third parties; (b) sending us an email message; (c) submitting your credit card or other payment information when ordering and purchasing products and services on our Site. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

Feast on Life Training collects and uses your personal information to operate its website(s) and deliver the services you have requested.

Feast on Life Training may also use your personally identifiable information to inform you of other products or services available from Feast on Life Training.

Sharing Information with Third Parties

Feast on Life does not sell, rent or lease its customer lists to third parties.

Feast on Life may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Feast on Life, and they are required to maintain the confidentiality of your information.

Feast on Life may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Feast on Life or the site; (b) protect and defend the rights or property of Feast on Life; and/or (c) act under exigent circumstances to protect the personal safety of users of Feast on Life, or the public.

Tracking User Behavior

Feast on Life may keep track of the websites and pages our users visit within Feast on Life, in order to determine what Feast on Life services are the most popular. This data is used to deliver customized content and advertising within Feast on Life to customers whose behavior indicates that they are interested in a particular subject area.

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by Feast on Life. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Feast on Life website.

Use of Cookies

The Feast on Life website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize Feast on Life pages, or register with Feast on Life site or services, a cookie helps

Feast on Life to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on. When you return to the same Feast on Life website, the information you previously provided can be retrieved, so you can easily use the Feast on Life features that you customized.

You can accept or decline cookies. Most Web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. If you choose to decline cookies, you may not be able to fully experience the interactive features of the Feast on Life services or websites you visit.
